## **RDC READER LICENSE TERMS AND CONDITIONS**

#### I. License

- a. RDC's third party content providers (collectively "Content Providers") grant to Subscriber and to Subscriber's Authorized Users (defined below) on the terms set forth in this Agreement, a non-exclusive, non-assignable, concurrent-use license to use the RDC Reader License solely for Subscriber's Regulatory Compliance Obligations. "Authorized User" means only employees and independent contractors, while performing their work for Subscriber. Subscriber understands and acknowledges that all use is subject, after reasonable notice, to restrictions and disclaimers that RDC's Content Providers publish from time to time.
- b. Subscriber and Subscribers' Authorized Users are licensed to use the RDC Reader License solely for access, search, retrieval, viewing, printing, and downloading for Subscriber's Regulatory Compliance Obligations. Printing and downloading are limited to insubstantial portions of the data, for temporary storage. All other use is prohibited. The removal or altering of any copyright or other notices within the RDC Reader License or using any portion of RDC Reader License for purposes of manual, automated or other machine-assisted indexing or classification of other publications is prohibited. The transmission of Content, as defined under Section III.a, (including, but not limited to, by way of e-mail, facsimile or other electronic means) is prohibited unless such transmission is between Authorized Users. Except as expressly provided for in this Agreement, Subscriber and Subscribers' Authorized Users may not modify, publish, transmit (including, but not limited to, by way of e-mail, facsimile or other electronic means), display, participate in the transfer or sale of, create derivative works based on, or in any other way exploit any of the Content, in whole or in part without the prior written consent of RDC's Content Providers.
- c. Subscriber will take reasonable steps to ensure that only Subscriber's Authorized Users use the RDC Reader License, and that Customer's Authorized Users do so in accordance with this Agreement.

## II. Express Restrictions

- a. Without limiting any other restriction on use set forth in this Agreement, the following limitations apply to make sure that all use is for Subscriber's Regulatory Compliance Obligations and will not impair RDC's Content Providers ability to market/license its products to other customers or other potential customers:
- (i) Subscriber is specifically prohibited from granting any use to any entity including, but not limited to, any school, library, college/university, corporation, business or organization that is not an Affiliated Entity of Subscriber.
- (ii) Subscriber shall not provide any material from the RDC Reader License to fulfill an interlibrary loan request or any other loan request from another library or organization.

## III. Intellectual Property

a. Subscriber acknowledges that the RDC Reader License consists of materials copyrighted by third parties and containing trademarks owned by third parties, and that RDC's Content Providers own the copyright of the compilations of these materials. The RDC Reader License contains copyrighted material, trademarks and other proprietary information owned by RDC's Content Providers, including without limitation, compilations, text, software, photographs, video, graphics, trademarks, service marks, logos, designs, and music and sound (the "Content"), and such Content is protected under U.S. copyright laws, U.S. trademark laws, and other intellectual property laws as well as international copyright and trademark laws and treaties. Subscriber acknowledges that its use of the RDC Reader License, including use by Subscriber's Authorized Users, must not infringe the rights of RDC's Content Providers or of any third parties.

b. Consistent with the fair-use provisions of the Copyright Act of the United States, Subscriber and Subscriber's Authorized Users are licensed to reproduce or store only insubstantial portions of the information provided under the RDC Reader License, resulting from specific searches for Subscriber's Regulatory Compliance Obligations. Subscriber and Subscribers' Authorized Users will not store or use, or allow to be stored or used, any portion of the product of the RDC Reader License in a searchable database without written permission of RDC's Content Providers or data/text mine or permit data/text mining of the product provided by the RDC Reader License. Nothing contained herein shall be construed as granting the Subscriber and its Authorized Users or any third party any interest in or to the product from the RDC Reader License or Content. All rights in and to the product from the RDC Reader License and Content are expressly reserved by RDC's Content Providers.

# IV. Warranty, Liability, Indemnity

- a. RDC's Content Providers do not warrant that use of the products from the RDC Reader License will be uninterrupted or error-free.
- b. RDC's Content Providers do not warrant the accuracy or completeness of the products from the RDC Reader License, or results obtained by using them. RDC and RDC's Content Providers disclaim liability for any offensive, defamatory, or infringing materials in the products from the RDC Reader License.
- c. Subscriber will take reasonable steps to ensure that Subscriber's Authorized Users will use the products from the RDC Reader License according to the terms of this Agreement, and that they will not bypass, or attempt to defeat, RDC's Content Providers', RDC's or Subscriber's security measures preventing unauthorized use of the products from the RDC Reader License.
- d. To the extent allowed by law, Subscriber shall indemnify RDC's Content Providers against any claims or losses, including reasonable attorneys' fees, arising in whole or in part from any violation by Subscriber of subparagraph IV.c.
- e. RDC AND RDC'S CONTENT PROVIDERS DISCLAIM ALL OTHER EXPRESS OR IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- f. To the extent allowed by law, neither RDC nor RDC's Content Providers will be liable for consequential or punitive damages, even if notified of their possibility.
